The Board of Directors would like to thank you for your interest in managing and coaching in Foster City Little League.

Managing and coaching are privileges, not rights, in Foster City Little League. You are appointed on an annual basis, and the fact that you had a team last season DOES NOT GUARANTEE that you will have a team this season. Should a situation arise in which your actions are deemed not "in the best interests of Foster City Little League", the Board has the power to remove you as a manager or coach. Managers are appointed by the President and approved by the Board of Directors.

Little League has instituted a mandatory background checking policy. Please fill out the separate form provided for this purpose.

The Little League manager must be a leader. All managers must recognize that they hold a position of trust. It is a responsibility in a program that deals with a sensitive and formative period of a youngster's development. It is required that a manager have understanding, patience and the capacity to work with all youngsters, The Manager must be aware that the attainment of exceptional athletic skill or the winning of games and championships is secondary, and that the teaching of good sportsmanship, teamwork, honesty, loyalty and respect for authority is of prime importance.

In order to manage in the Majors Division, a person must have at least two years official coaching experience within Foster City Little League, or the equivalent. In order to Manage in the AAA and AA level, a person must have at least one year of official coaching experience, within Foster City Little League, or the equivalent.

The selection of managers and coaches is in the jurisdiction of Foster City Little League, and is not subject to intervention from the District, Region or Little League Headquarters.

A Majors or AAA division manager must agree to coach only one team during the Little League season, and may not manage concurrently in any other baseball or softball program including but not limited to Senior, Pony, Colt, Babe Ruth, Joe DiMaggio, High school or ASA.

Managers and coaches in all Baseball and Softball divisions are asked to umpire at least two (2) games in a division other than that in which they manage or coach.

The Manager shall be responsible for the conduct of his or her players, team parents, and team volunteers at all league games and practices. The manager must demonstrate that he/she has an appreciation for the philosophy of Little League, and cooperate with the Board of Directors and others in making the program of mutual benefit to all youngsters.

All managers MUST show by example that they respect the judgment and position of authority of the umpire, and at the same time instill in their players a respect for authority of adult leaders in the league. The manager must exercise a leadership role, but at the same time leave the game in the hands of the players. The manager must, within Little League rules, provide an opportunity for every player to take part in every game.

The Manager must also encourage players at every opportunity. The Manager must know the playing Rules of Little League Baseball and be able to interpret them correctly. The Manager must make every possible effort to correct any violation of the rules before they occur to prevent any protest situation. It is also recommended that all managers have a basic knowledge of first aid and safety.

The Manager/Coach must also be aware that the Board of Directors, by the power vested therein and within the League Constitution, has the power to remove any Manager/Coach from his or her position if his or her actions are viewed as detrimental to the team and/or to the well being of the league. The Manager/Coach does have the right to a hearing before the Board of Directors in such cases, as outlined in the bylaws.

Thank you for submitting an application to manage / coach for the spring, 2008 Little League season. For those who were involved in the 2007 season, I'm sure you noticed that the league invested heavily in training clinics and a partnership with the Positive Coaching Alliance in an effort to create a positive and rewarding experience for all participants, including Managers and Coaches.
